# RULES HELP EVERYONE BY MAKING YOUR STAY WITH US MORE ENJOYABLE AND SAFE. ANY ACTIVITY THAT INFRINGES UPON THE RIGHTS OF OTHER CAMPERS IS FORBIDDEN. THESE RULES ARE STRICTLY ENFORCED TO HELP YOU!

#### **GENERAL RULES**

- ONE TRAILER OR RV, 2 VEHICLES, max. 8 people (4 Adults/4 Kids) per site. Car passes must be visible at all times.
- CAMPERS USE all facilities at their own risk. PARENTS are
  responsible for their kids at all times. Children under 8 yrs. must
  have ADULT SUPERVISION AT ALL TIMES, in the
  playground, bathhouse, beach and all VG functions. KIDS under
  18 must never be left alone in Campground under any
  circumstances.
- 3. SPEED LIMIT IS 5 MPH THROUGHT ENTIRE CAMPGROUND.
- 4. NO CHILD UNDER 18 YRS OLD IS ALLOWED OFF THEIR SITE AFTER 11PM unless accompanied by a Parent.
- 5. **DO NOT** cross occupied sites.
- 6. **DO NOT** cut any live or dead trees or shrubs.
- 7. **FIRES** restricted to stoves or fireplaces. Do not move fireplaces.
- 8. **MOTORCYCLES & MOTORBIKES** allowed entering or leaving Campground. **NO BICYCLE** riding after dark (kids under 16yrs must wear helmet; it's the Law in MA).
- 9. GOLF CARTS MUST PROVIDE COPY OF INSURANCE AND ONLY INSURED OPERATORS MAY DRIVE THEM. NO DRIVING GOLF CARTS AFTER 11PM-NO SPEEDING/NO DRINKING AND DRIVING!!!
- 10. QUIET HOURS are between 11pm-10am. Your radios should be played for your enjoyment, not your neighbors, keep it down. RADIOS OFF at 11pm, FIRES OUT at midnight-SOCIALIZING inside at 1am. Any annoyances should be reported to the office immediately.
- 11. ANYONE (CHILD OR ADULT) PARTAKING IN BEHAVIOR THAT DOES NOT PROMOTE GOOD FAMILY VALUES i.e. swearing, excessive drinking, infidelity or drug use, will be removed from the Campground.
- 12. VILLAGE GREEN WILL ONLY ACCEPT TRASH IN OUR BLUE TRASH BAGS, WHICH ARE SOLD IN THE STORE FOR \$1.00EA. Put filled trash bags near the dumpster by the entrance. This is a 'pay if you use' policy New Recycling Program
- 13. Gate Key Cards are \$20.00 each (refundable upon return). 2 Cards are allowed per site. Gate Key Cards are for Seasonal Campers only. Do not lend out your card or you will lose Gate Key privileges.

#### **POND**

- NO LIFEGUARD is furnished. SWIM at your own risk. A responsible adult must accompany ALL CHILDREN under 18.
- 2. **FISHING** is catch & release only. **NO FISHING** off spillway, beach area or area surrounding beach.
- 3. NO GLASS CONTAINERS ON THE BEACH.

#### PETS

- NO MORE THEN 2 DOGS PER SITE.
- 2. **DOGS** must be friendly & leashed at all times.
- 3. Do not leave **DOGS UNATTENDED**.
- 4. **DOGS** that bark continuously must be muzzled.
- DOG WALKERS must have pooper-scoopers with them when walking dogs. DOG'S STOOLS must be picked up and put in trash. (Not in bushes, fireplaces or buried)
- NO DOGS in swimming area, on the beach, in the store or in the bathhouse.
- 7. All pets must have a **RABIES CERTIFICATE** upon arrival.

#### **VISITORS**

- ALL VISITORS must register in office. Failure to register visitors will result in loss of visitor privileges
- 2. NO VISITORS allowed after 8pm.
- 3. **ALL DAY VISITORS** must leave by 11pm.
- 4. **VISITOR PARKING** located in front of office by the road.
- 5. NO VISITOR PARKING in camping area.

#### **SMOKING/LIQUOR**

- NO SMOKING ANYTHING on beach, in store, in Pavilion, Recreation Room, Bathhouse or Playground (per Board of Health) PLEASE POLICE YOUR BUTTS! (PICK THEM UP)
- 2. NO OPEN ALCHOL BEVERAGES WHILE DRIVING.
- 3. **BEER, WINE & PRE-MIXED DRINKS ONLY** will be allowed at Campground functions. (Dances, Beach, Ball field)
- NO LIQUOR BOTTLES or consumption of SHOTS will be allowed at Campground functions. (Dances, Beach, Ball field).
- 5. ALL LIQUOR BOTTLES must remain on site in a secure area.
- NO ONE UNDER THE AGE OF 21 will be allowed to consume alcohol at Village Green Family Campground. This is the LAW.
- 7. ANYONE DEEMED, BY MANAGEMENT, TO HAVE CONSUMED MORE THAN HIS/HER SHARE OF SPIRITS WILL BE ASKED TO RETIRE TO THEIR SITE.
